

"JOBZ" PRIVACY POLICY

Introduction

This Privacy Policy ("Policy") governs the collection, use, and disclosure of personal data when you access or use our website, Jobz, and the services we provide ("Services"). By using our website, you acknowledge that you have read, understood, and agreed to the terms of this Policy. If you do not agree with this Policy, please refrain from accessing or using our website and Services.

Information We Collect

- Personal Information: When you use our website or register an account with Jobz, we may collect
 personal information that can identify you directly or indirectly. The types of personal information
 we may collect include:
- Your name, email address, and contact information.
- Your job preferences, such as the type of service you are seeking or offering.
- Your payment information, such as credit card details or other payment-related details.
- Any other information you provide voluntarily when using our website or interacting with our Services.
- Usage and Log Data: We may collect certain information automatically when you visit or use our

Therefore, while we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security.
